IMPORTANT ARTICLES OF OUR MOI TO KEEP IN MIND:

- **Articles 11.15 and 14.20:** Only Members in good standing as described in these Articles are allowed to assign their voting rights with this Form to a proxy;
- **Article 14.29:** *A Member may be represented at a Members' Meeting by proxy, who need not be a Member of the Association. A proxy shall not be entitled to delegate his authority to act on behalf of the Member to another person. A Member may appoint a single person as proxy or two persons concurrently as proxies, to act in the alternative should one of them not be able to be present at the meeting, provided that no person, excluding the developer, shall be entitled to accept and/or be the holder of, more than 5 (five) proxy appointments;*
- **Article 14.33:** *The form appointing a proxy shall be preferably delivered to the Association 7 (seven) days prior to the Members' Meeting, before the proxy exercises any rights of the Member entitled to vote at a Members' Meeting.*
